## **2021 NAUPADA CASE**

**NIA** seizes weapons, devices during searches at 6 locations in fake currency case

**EXPRESS NEWS SERVICE** MUMBAI. MAY 11

THE NATIONAL Investigation Agency (NIA) seized several incriminating material during searches at half-a-dozen locations in Mumbai in the 2021 Naupada case relating to seizure of high quality fake Indian cur-

rency notes (FICN). The seizure included sharpedged weapons, digital devices and documents, which is a strong corroboration of NIA's earlier investigational findings establishing a direct connection with the D-Company, fugitive gangster Dawood Ibrahim's gang, in the fake currency racket,

an officer said. "Thus the role of the D-Company has been prima facie established in the circulation of FICN in India during the NIA investigation into the case," the officer

The case related to the seizure of counterfeit Indian currency notes of Rs 2,000 denomination. Two persons were arrested in the case, originally registered at Naupada police station, Thane city, on November 18, 2021, under relevant sections of IPC and the Unlawful Activities (Prevention) Act, 1967. The accused, identified as Riyaz and Nasir, both residents of Mumbai, are currently in judicial custody.

The Thane police had carried out searches and also chargesheeted the accused in the high-profile case, which was later taken over by the NIA and re-reg-

On Wednesday, the NIA raided several properties of the accused and suspects, mostly houses and offices, as part of its continuing investigations in the case.

## IMD issues heatwave warning for Mumbai, neighbouring dists

THE INDIA Meteorological Department (IMD) Thursday issued a heatwave warning for Mumbai along with Thane, Palghar, Raigad and neighbouring districts in Konkan region of Maharashtra for the next days.

This is the first time in this month and the fourth time in this season that a heatwave warning has been issued for Mumbai.

The IMD's Santacruze observatory recorded 36.9 degrees Celsius, a three-degrees jump in the past 24 hours.

The Colaba observatory recorded 34.2 degrees Celsius. Scientists from the IMD said that this situation will continue for two days and the situation may ease from May 13 onwards.

der. According to the police offi-



"SIT is trying to ignore all the testimonies that point to the fact that Darshan was facing caste discrimination from his roommate, classmates and other people in the institute and was deeply affected by it. The SIT which is investigating the crime of abetment to suicide and caste atrocity, is not even looking at the angle of caste discrimination and has instead pinned the blame on one student in a separate matter," a statement issued in Mumbai by Darshan's father, Rameshbhai Solanki said.

Solanki, while releasing the statement was accompanied by former MP, Dr Bhalchandra Mungekar.

Dr. Mungekar said, "The SIT is purposefully sidelining the angle of caste discrimination for reasons best known to them. The castebased system and its existence on IIT campus has caused Darshan's death." Alleging that the SIT is trying to cover up caste-based discrimination, the statement by Rameshbhai which is sent to the Chief Minister, Home Minister, Commissioner of Police and also

to the National Commission for Scheduled Castes, demands immediate intervention so that "crucial evidence is not lost."

According to Darshan's sister Ianvi Solanki, the family has not been provided clone copies of the seized electronic devices even after demanding it repeatedly. "We fear that more such instances that can show that he has faced castebased discrimination will be buried under the guise of investigation," read the statement.

## **KILLED HIS WIFE IN 2018**

## Labourer, held for killing contractor, sent to police custody for seven days

**EXPRESS NEWS SERVICE** MUMBAI, MAY 11

THE 49-YEAR-OLD labourer, who was arrested for allegedly murdering his contractor in south Mumbai on Wednesday, was produced before court on Thursday and remanded in police custody for seven days. The police said that the accused identified as Brijeshkumar Suresh Prasad, who has been booked for murder under Indian Penal Code and Arms Act, had killed his wife too in 2018 suspecting that they were in an ex-

tra-marital affair, police said. An investigator said, "Prasad claims that he had killed his wife Sunita by assaulting her with an iron broom in June 2018 over a mere suspicion. We suspect that he was in guilt for killing his wife and he went back to Dongri after coming out of Nagpur jail on January 26 and worked as a cleaner under the contractor Dharma Nadar. He worked with Nadar for months.'

The police added that the accused claims that while working under Nadar, he somehow man-

his wife (Sunita) and Nadar were in an illicit relationship following which Prasad decided to kill him. "We are still trying to ascertain as to how exactly did he get to know about their affair, but we suspect that Prasad and Nadar must have sat for drinks (alcohol) during which the latter must have mentioned about it," said an investigator. The police said that Prasad

The police said that Nadarwas also rushed to JJ hospital where he was declared dead during treatment. His postmortem was conducted on Thursday.
